## • STUDENT/ACTIVE MILITARY MEMBERSHIP

✓ Open to any person of Portuguese ancestry over the age of 18 that can trace their roots to the country of Portugal, islands of the Azores or Madeira, whether you were born or

immigrated to the United States, enrolled as a student in a trade school, college or university or active military personnel in the armed forces of the United States

✓ Includes all the Individual Membership benefits

#### SOCIAL MEMBERSHIP

- ✓ Open to any person who does not qualify under the other membership classes, but wish to support the Society
- ✓ Not eligible to serve on the Board of Directors and as an officer
- ✓ Not eligible to vote for the Board of Directors

- ✓ General access to the facility
